2.2 Location

Rostock is located in the W-part of the Baltic Sea, at the estuary of the river Warnow, Lat: 54°09'N Long: 012°06'E.

Rostock is the largest port of Mecklenburg-Vorpommern. In 2023 the total amount of the cargo handling achieved a volume of 32,2 milion tons.

2.3 Tidal range and flow

Tide is insignificant, but strong winds from S directions may lower and gales from N directions may raise the water level up to +/-1.5m.

Weather

Prevailing winds: Westerly

Ice

The river Warnow at the old City port as well shallow waters in the estuary normally freeze in the winter, but the channels are kept open as long as possible, and the ports are rarely closed.

Density

Because of the river Warnow the water in the port of Rostock is brackish with a density of approx. 1,008 kg/m³.

2.4 Restrictions and Shipmax

No obstacles, no locks, bridges etc.; no restrictions for entering at night normally. Depending of port and berth usually Rostock can handle vessels up to LOA 330 m or BOA 50 m with draught of max. 13,00 m. Vessels which exceed defined bert-parameters are requested to obtain a permission from Port Authority, especially if bound for Fracht- und Fischereihafen as well old City Port.

2.5 Anchorages

In the roads, 2-6 nm NW of Warnemunde, there are two recommended anchorages with a depth of 13-17 m, bottom mud and sand. They are unsheltered from W, N and NE winds. Anchorage No.2 is reserved for tankers and vessels with dangerous cargo; Anchorage No.1 for other vessels.

2.6 Approach, Traffic Schemes, Sea buoys, fairways and channels

Boy "Rostock" is the approach for the Ports of Rostock situated at the Bay of Mecklenburg and leading with a buoyed and lighted fairway, approx. 9,1 nm in length and max. 15 m draught to Warnemuende and the Ports of Rostock.

2.7 Vessel Traffic Service (VTS Centre)

"Warnemuende Traffic" monitors permanently all traffic between the approach buoy, anchorage and the Ports of Rostock. Each vessel exceeding LOA of 30 m has to be contacted via **VHF ch 73** minimum 30 min before entering traffic area.

Minimum bollard pull of 30 tons is required as well 150 tons by assistance with 4 tugs. Tugs available up to 52 tons bollard pull.

Vessels bound for berth no. 3 at oil harbor exceeding LOA 220m are requested to order minimum 4 tugs for arrival and 3 tugs for departure.

2.15 Maritime Emergency / Rescue

The DGzRS (Deutsche Gesellschaft zur Rettung Schiffbrüchiger = German Maritime Search and Rescue Service) is responsible for the maritime search and rescue service in the German areas of the Baltic Sea (VHF Ch. 16 – Bremen Rescue).

The Central Command for Maritime Emergencies (CCME) (Havariekommando) is a joint institution of the German Federal Government and the Federal Coastal States. It was established to set up and carry out a mutual maritime emergency management in the Baltic Sea.

2.18 Dangerous Goods

Notifications about dangerous or polluting goods carried on board has to be reported upon arrival and at the latest at the departure of the ship from the port.

Dangerous Cargo can be handled, prior notice to Port Authority is compulsory.

2.19 Port State Control

2.20 Maritime Declaration of Health

2.21 Disposal of Garbage and Sludge

The disposal of ship generated waste under the scope of Annexes I, II, IV, V and VI of the MARPOL Convention is subject to the law governing the disposal of ship-generated wastes and cargo residues in the federal state of Mecklenburg-Vorpommern (SchAbfEntG M-V).

Therefore, accordingly, Port reception facilities are available.

In the interest of protecting the marine environment, all ships are required to dispose of their wastes and cargo residues in each port of Call. The Notification of waste disposal is to be made electronically via the input interface of the National Single Window (NSW). For further specific Information please contact the Port agents (See attached List) or Port authority.

2.22 Ballastwater Treatment

Since enforcement of the International Ballast Water Convention in 2024 the D2-Standard apply to the treatment of ballast water accordingly. A limited transiton period has expired. Depending on the BWTS used holding times must be observed in accordance with the Type Approval of the system.

2.23 Seawage Treatment

The discharge of ship sewage including from exhaust gas purification systems into harbour waters is **generally prohibited without a discharge permition** from the responsible water authority.

Ships and watercrafts larger 400 BRZ equiped with an approved, operational and operating seawage treatment system may allowed to discharge treated ships seawage. This regulation does not apply for seawage treatment system approved according to MEPC 2 (VI).

2.24 Dry Bulk Cargo Handling

For safe loading and unloading of bulk carriers harmonized ruel and procedures apply under the scope of Annexes I, II, III, IV, V and VI of the EU Directive 2001/96/EG.

A consistens exchange of information between the master of bulk carriers and the bulk terminal is required to ensure by means of coordinated loading/unloading sequences and safety checklists.

2.25 Veterinary Station

Handling of animal products and live animals are available; prior the permission of veterinary station is compulsory.

2.26 Diving

Diving operations can be undertaken. There are several diving companies in Rostock.

2.27 Repair Facilities

Repair work can be undertaken. There are several companies in Rostock available.

2.28 Bunkering

Bunkers can be supplied in the anchorage no. 2, in the ports via barge or truck. Also the port authoritie examines and grants permit for bunkering of deep-frozen liquefied natural gas (LNG).

Fresh water can be supplied via wharf. Please contact the port agents (see attached list) or port operators.

Cargo Handling and Facilities

The above ship berths are available with more than 11.000 meters of quayside. The port is equipped with modern ship handling equipment and special facilities for example Ship unloaders for discharging coal; Cranes with hoppers for discharging coal, fertilizer, road building materials.

One ship loader connected to the warehouse by conveyor belt for loading fertilizer (urea) and calcium ammonium nitrate (CAN). Two ship loaders (grain terminal) connected to the silos of the different shippers and Six berths for ro-ro-vessels.

Intermodal Traffic: There are more than 30 block trains at the terminal for intermodal traffic weekly.

Ferry Services: The port has a ferry terminal with four berths offering several times daily routes to Gedser (Denmark) and Trelleborg (Sweden). One of the berths is also able to handle railcars. A 1 km long road flyover links the ferry terminal with the expressway A19 Rostock-Berlin and A20 (coastal expressway).
